## **PRESIDENT'S REPORT**

The H1N1 Influenza Pandemic certainly presented additional challenges for perioperative nurses during the winter. Operating sessions were cancelled or curtailed due to a lack of post-operative beds, particularly in the ICU/HDU areas and increased sick leave across the nursing profession. Despite these challenges perioperative nurses continued to provide safe, quality care for their patients. I would also like to acknowledge the hard work and professionalism of all of our nursing and healthcare colleagues during this difficult time.

The NSW OTA applied to the Royal College of Nursing Australia to become an Authorised Provider of Endorsed Courses (APEC) and sent two Executive members to an APEC training workshop in July. Consequently, these Executive are now authorised to endorse activities provided by NSW OTA and allocate Continuing Nurse Education (CNE) points to each. This includes our annual Conference, seminar days and other educational activities. This provides assurance for our members that these activities meet educational standards set by the RCNA. The OTA Executive believe that it is important to implement this process now as it will assist our members in developing a professional portfolio in preparation for National Registration.

A capacity group attended the Anaesthetic and Recovery Seminar day held at the 3M Education Facility in June. The day was a great success and we thank the speakers for their interesting presentations and the organising team led by Allannah Hazelgrove, the OTA Education Officer. Many thanks also to our industry partners, in particular 3M, for their continuing support.

The Zones have also been busy holding General Meetings, AGMs and Education Days, and congratulations must go to the Zone Committee members for their hard work organising these events.

I am pleased to report that three resolutions with a perioperative focus were passed at the recent NSWNA 64th Annual Conference. The first resolution called for the immediate implementation of the ACORN 2008 staffing standard as the Reasonable Workload Tool (RWT) for Operating Suites and also that 3.5 FTEs be recognised as the minimum staffing numbers required per operating room to ensure adequate supervision and education for beginning practitioners. I also had the opportunity to ask Minister Della Bosca if he would give an assurance that the ACORN 2008 staffing standards would be implemented immediately as the RWT for Operating Suites across NSW. He replied that he was not aware of the release of the ACORN 2008 Standards and that he would seek information from his Department and report back to the NSWNA. We will wait for his reply to be published in the Lamp. In his favour, he did return after morning tea and take an additional 30 mins of questions from the delegates (a number of whom received the same reply I did) and all without the usual support of the Director General.

The second resolution called for the DOH to commence negotiation regarding the implementation of subsequent updated standards with the NSWNA, once the implications of the changes had been assessed, and that these updated standards be adopted as the RWT as a matter of priority following their release.

The third resolution called upon the NSWNA to investigate the OH&S risk posed to perioperative nurses by smoke plume.

I encourage members to visit the NSW OTA website as Lilian Blair, the Editorial Liaison Officer and Website Designer has worked tirelessly to develop and reformat the site and make it more user friendly and informative.

The Conference Sub-Committee has been busy planning for the Annual Conference to be held at Newcastle 11<sup>th</sup> - 13<sup>th</sup> March 2010. A call for abstracts has been released with a closing date of 16<sup>th</sup> October 2009 and I encourage all perioperative nurses, novice to expert, to consider submitting a paper. The Committee is particularly interested in receiving papers relating to patient safety, risk management and quality issues, as these subjects will form the overall focus of the education agenda. Also, start planning your outfit for the Masquerade Ball to be held in the magnificent Concert Hall of the City Hall building on Friday March 12<sup>th</sup>, this event is sure to be a highlight of the social calendar in 2010.

**ACORN UPDATE by  
Fran O'Brien, NSW Director**

Board Meeting was held 10<sup>th</sup> and 11<sup>th</sup> July in Adelaide.  
The main points discussed:

- ACORN is developing a professional portfolio template for all members. This will be provided on a USB and distributed free of charge to members.
- Generic count sheets are also being developed which when finalised will be circulated to the Local Associations for comment.
- The updated Scrubbing, Gowning and Gloving DVD should be available for sale in approximately 8-12 weeks.
- The Standards are continuing to be reviewed. Thank you to everyone that has had involvement. The current Standards will be available online to members around October.
- AS 4187 remains 'up in the air' as Standards Australia no longer wish to continue with this Standard. The key stakeholders continue to lobby Standards Australia about the importance of maintaining this Standard.
- Preparation for 2010 ACORN Conference is gathering momentum. Many stands have already been allocated and the call for Abstracts close 27<sup>th</sup> November 2009. The Marketing Committee has been busy promoting Perioperative Nurses Week which will commence on 12<sup>th</sup> October, as this was the date that ACORN was established. The ACORN website will be upgraded shortly making it more interactive and incorporating the Special Interest Groups. The ACORN Annual Report will be circulated electronically next year for those who wish to receive it via this method. A letter will be sent out shortly informing members of this new option.
- Please make sure that you put 19<sup>th</sup>-22<sup>nd</sup> May 2010 in your diaries because Tracy and I hope to see you all 'going West' to the ACORN Conference in Perth, WA.

### Transition to Specialty Nursing Program

The NSWOTA is in discussions with NSW Health regarding the opportunity to participate in an exciting project already being used by ICU and ED RNs. A perioperative transition program would provide a competency based education course to assist RNs transitioning into perioperative nursing and available across NSW in flexible mode. Discussions are in their early stages with NSW Health, but with a framework already in place, courtesy of the ICU/ED programs, we hope that speedy progress can be made to develop the required perioperative content.

### Perioperative Modeling Care Project

Members of the Executive met with Mary Chiarella to finalise plans for commencing the project. The goal of the project is for perioperative nurses in NSW public hospital to identify opportunities and change the way care is delivered in order to make better use of available resources to provide optimal patient care.

The project will consist of twenty nursing teams from all Area Health Services in NSW. Two team leaders from each team will attend four workshops beginning in November 2009 and continuing through 2010. The team leaders will then work with their workplace teams to select and action a workable plan to bring about changes in their workplace.

Invitations will soon be sent to Area Directors of Nursing seeking the participation of perioperative nurses in their Areas.

## Perioperative nurses, we need your help!

Self-assessment of competence provides an effective means that may assist perioperative nurses to maintain and improve their practice, by identifying strengths and areas for further improvement. The Revised Perceived Competence Scale (Rev-PCS) has been developed based on perioperative practise, (Gillespie et al, 2008) and we now wish to undertake further research, to scientifically test this scale.

Consequently, we will soon be surveying all members of ACORN and would like to invite you as an ACORN member to complete a questionnaire about your perceptions of competence as an OR nurse.

This questionnaire will be mailed to you and we are seeking your cooperation in filling it out and returning it to us (in pre-paid envelope). The survey is anonymous, and your consent implied by the return of the completed survey form.

This research is jointly funded by the NSW Operating Theatre Association Inc. (NSW OTA) and the Perioperative Nurses Association of Queensland (PNAQ).

### Undergraduate Nurses - Where are you??

Anecdotal evidence from several members indicates that some operating suites are not getting the same numbers of undergraduate nursing students on clinical placement as in previous years. Certainly at Prince of Wales/Sydney Children's Hospital (POW/SCH), we have had very few undergraduates this year to date. The universities who offer perioperative electives eg ACU and UTS still have large intakes and clinical placements, but it is some of the other universities without the specialty electives that are of concern. In discussion with a colleague at University of Western Sydney (UWS), it seems that curriculum changes at UWS have meant that surgical nursing subjects are now offered in 2<sup>nd</sup> year. This means that opportunities for students to undertake a clinical placement in operating theatre now occur in 2<sup>nd</sup> year not 3<sup>rd</sup> year. According to my UWS contact, a number of operating theatres are refusing to take 2<sup>nd</sup> year undergraduates. The reasons for this may be that the criteria set by hospitals stipulating the number and year of students they are willing to accept state 3<sup>rd</sup> year only. At POW/SCH we have been in touch with our hospital's undergraduate coordinator to ensure that our criteria has been altered to include 2<sup>nd</sup> and 3<sup>rd</sup> year. So if you have also seen a reduction in numbers of undergraduates, it might be worth checking with your local or Area undergraduate coordinator and altering your criteria. Personally I do not mind what year the undergraduates are when they come to us, we are happy to provide them with good clinical experiences and encourage them to return later in their programs if an elective is offered and certainly promote opportunities as New Graduates in the perioperative specialty.

I would be interested to hear from you regarding whether you are experiencing similar reductions in undergraduates and the possible reasons.

Sessions included: malignant hyperthermia, Margaret Nowak described the experience of the older perioperative nurse, the importance of Fluid Balance of the surgical patient. Jan Poole Hill was announced the winner of the \$1250 J&J Education Award. Chloe Owens and Leah Humphreys presented a brief paper on their experience of speaking at the NSW OTA Annual State Conference in 2009, Mary Chiarella presenting on legal and ethical issues. A panel discussion including Mary, Ros Berryman together with local perioperative nurses and doctors investigated issues included in a hypothetical scenario. ### **Saturday 22<sup>nd</sup> August Zone 7 Canberra Education Day & AGM held at Kamberra Wine Centre**

Dr Lois Hamlin attended on behalf of the NSW OTA Executive There were approximately 50 perioperative nurses and 8 companies participating with trade displays, including Big Green, Device Technology and Multigate. Sessions included: Mercy Ships in Benin, organ donation and a session from Stryker. Additionally, there was a lively, interactive session about dealing with the erosion of supernumery time for New Graduate and other new nurses moving into the perioperative environment. One topic arising out of the debate was a request for the OTA to develop standardised, competency assessment tools.
